THE SARAWAK BIODIVERSITY (DECLARATION OF PROTECTED RESOURCES) NOTIFICATION, 2015

In exercise of the powers conferred by section 21(1) of the Sarawak Biodiversity Centre Ordinance, 1997 *[Cap. 24]*, the Sarawak Biodiversity Council, with the approval of the Minister for Resource Planning and Environment, declares the biological resources, namely the micro-organism species, *Botryococcus spp.*, as protected resources for purposes of the Ordinance with effect from the 5th day of March, 2015.

THE LAND CODE

THE MAPAI LAND DISTRICT (MIXED ZONE LAND) DECLARATION ORDER, 2015

(Made under section 4(1))

In exercise of the powers conferred upon the Minister by section 4(1) of the Land Code *[Cap. 81 (1958 Ed.)]*, the following Order has been made:

Citation and commencement

1. This Order may be cited as the **Mapai Land District (Mixed Zone Land) Declaration Order, 2015**, and shall be deemed to have come into force on the 13th day of March, 2013.

Declaration of Mixed Zone Land in Sibu Division

2. The area of land described in the Schedule has been declared Mixed Zone Land.

SCHEDULE
SIBU DIVISION

MAPAI LAND DISTRICT

All that parcel of land situated at Nanga Tada, Kanowit, containing an area of 6,089.9 square metres, more or less, and described as Lot 19 Block 7 Mapai Land District.

(The boundaries of the land described above are more particularly delineated on Land and Survey Department Miscellaneous Plan No. MP 3/5-184, deposited in the office of the Superintendent of Lands and Surveys, Sibu Division, Sibu.)
